# Privacy Policy Marketing\_Form Contacts

Dear User,

Pursuant to the current national legislation in the field of privacy and in compliance with the provisions of the GDPR 2016/679 (General Data Protection Regulation), VINCI Energies Italia S.r.l. (hereinafter "VEI") provides you with the information regarding the processing of your personal data, based on the principles of fairness, lawfulness, transparency and protection of your privacy and your rights.

## 1. Purposes of the Processing

With reference to these data we inform you that:

When filling out the contact form, you will be asked for your Identifying Data, including but not limited to: your first name, last name, telephone number, company you belong to, function and e-mail address.

Subject to your free and informed consent, your Data is processed to follow up your contact request and for marketing purposes (i.e. promotional, commercial and advertising activities). Specifically: sending material and advertisements related to the products and/or services marketed by VEI or other VINCI SA Group company related to it; sending emails, messages via app, promotional sms and sending newsletters etc.

#### 2. Access to Data

The Data may be made accessible for the purposes mentioned in Art. 1:

- -to employees, collaborators of the Data Controller or VINCI SA Group companies (in Italy and abroad), in their capacity as person in charge or data processor, if any;
- -to third party companies or other entities (by way of example, credit institutions, professional firms, consultants, insurance companies for the provision of insurance services, control bodies, companies possibly in charge of the installation, maintenance, updating and, in general, the management of hardware and software etc) that carry out outsourcing activities on behalf of the Data Controller, if applicable, appointed as external data processors pursuant to art. 28 GDPR.

#### 3. Data transfer to a third country and/or international organization

Your Personal Data will not be transferred outside the European Economic Area (EEA).

### 4. Processing Methods and Retention Period

The processing of Personal Data will be mainly carried out with electronic or automated means, using methods and tools suitable to guarantee the security and confidentiality of the data, in compliance with the provisions of current national legislation and GDPR 2016/679. In particular, all technical, IT, organisational, logistical and procedural security measures will be adopted, in order to guarantee the minimum level of data protection required by law, allowing access only to the persons in charge of the processing by the Data Controller or the Data Processors designated by the Data Controller.

The Data will be processed for the time necessary to fulfil the purposes set out in point 1. Unless there are legal obligations to retain the data, after this period of retention, the Data will be destroyed or anonymized.
